Trade Regulation and Antitrust

Healthcare Law

Mr. Dibble has represented plaintiffs and defendants in antitrust matters involving hospitals, universities, physician services, medical devices, insurance and pharmaceuticals. He has represented the acquired company in an acquisition involving a medical device manufacturer. He has litigated physician recruitment agreements, various commercial disputes involving hospitals, physician practices, health care contracts and other commercial health care related matters.

He has represented hospitals in Utah and Idaho on a broad range of matters. He currently represents Steward Health Care Hospitals, including Davis Hospital and Medical Center, Salt Lake Regional Medical Center, Jordan Valley Medical Center and its West Valley campus, and Mountain Point Hospitals.
